The APR report for HOPWA competitively selected grantees provides annual information on program accomplishments that supports program evaluation and the ability to measure program beneficiary outcomes related to: maintain housing stability; prevent homelessness; and improve access to care and support. Reporting is required for all HOPWA competitive grantees. The public reporting burden for the collection of information is estimated to average 55 hours per manual response, or less if an automated data collection and retrieval system is in use, along with 60 hours for record keeping, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information. Grantees are required to report on the activities undertaken only, thus there may be components of these reporting requirements that may not be applicable. This agency may not conduct or sponsor, and a person is not required to respond to, a collection of information unless that collection displays a valid OMB control number.

Overview. The Annual Progress Report (APR) provides annual performance reporting on clients' outputs and outcomes that enables an assessment of grantee performance in achieving the housing stability outcome measure. The APR fulfills statutory reporting requirements and provides the grantee and HUD with the necessary information to assess the overall performance and accomplishment of the grantee's program activities under the approved goals and objectives.

HOPWA competitive grantees are required to submit an APR for each operating year in which HOPWA grant funds were expended. Information on each competitive grant is to be reported in a separate APR. Grantees must complete Parts 1-5 on standard reporting elements. Grantees approved for "Other Activities", as detailed in their grant agreement, are requested to adapt the APR to report on their unique program accomplishments.

In addition, grantees must comply with the Federal Funding Accountability and Transparency Act 2006 (Public Law 109-282), which requires grant recipients to provide general information for all entities (including contractors and sub-contractors) receiving \$25,000+ in federal funding.

Continued Use Periods. Grantees that received HOPWA funding for new construction, acquisition, or substantial rehabilitation are required to operate their facilities for HOPWA-eligible beneficiaries for a ten (10) year period. If no further HOPWA funds are used to support the facility, in place of filing the APR, the grantee must submit an Annual Report of Continued Project Operation throughout the required use periods. This report is included in Part 5E Annual Report of Continued Use for HOPWA Facility-Based Stewardship in this APR. The required use period is three years if rehabilitation is non-substantial.

Record Keeping. Names and other individual information must be kept confidential, as required by 24 CFR 574.440. However, HUD reserves the right to review the information used to complete this report for grants management oversight purposes, except for recording any names and other identifying information. **In the case that HUD must review client-level data, no client names or identifying information will be retained or recorded. Information is reported in aggregate to HUD without personal identification. Do not submit client or personal information in data systems to HUD.**

In connection with the development of the Department's standards for Homeless Management Information Systems (HMIS), universal data elements are being collected for clients of HOPWA-funded homeless assistance projects. These project sponsor records would include: Name, Social Security Number, Date of Birth, Ethnicity and Race, Gender, Veteran Status, Disabling Conditions, Residence Prior to Program Entry, Zip Code of Last Permanent Address, Housing Status, Program Entry Date, Program Exit Date, Personal Identification Number, and Household Identification Number. These are intended to match the elements under HMIS. The HOPWA program-level data elements include: Income and Sources, Non-Cash Benefits, HIV/AIDS Status, Services Provided, Housing Status or Destination at the end of the operating year, Physical

Disability, Developmental Disability, Chronic Health Condition, Mental Health, Substance Abuse, Domestic Violence, Medical Assistance, and T-cell Count. Other HOPWA projects sponsors may also benefit from collecting these data elements. HMIS local data systems must maintain client confidentiality by using a closed system in which medical information and HIV status are only shared with providers that have a direct involvement in the client's case management, treatment and care, in line with the signed release of information from the client.

Operating Year. HOPWA competitive grants are awarded for a three-year period of performance with APRs submitted for each of the three operating years. The information contained in this APR should reflect the grantee's operating year with the beginning date determined at the time the grant agreement is signed. Project sponsor accomplishment information must coincide with the operating year this APR covers. Any change to the period of performance requires the approval of HUD by amendment, such as an extension for one additional operating year. A renewal grant start date would be coordinated with the close out of the existing grant.

Grantees with an approved extension period of less than 6-months must submit the APR for the third year of the grant term at the end of the approved extension period and incorporate data from the additional months. Grantees with an approved extension period of 6-months or more must turn in an APR at the end of the operating year and submit a separate extension APR at the end of the extension period.

Final Assembly of Report. After the entire report is assembled, number each page sequentially.

Filing Requirements. Within 90 days of the completion of each operating year, grantees must submit their completed APR to the CPD Director in the grantee's State or Local HUD Field Office, and to the HOPWA Program Office: at HOPWA@hud.gov. Electronic submission to HOPWA Program office is preferred; however, if electronic submission is not possible, hard copies can be mailed to: Office of HIV/AIDS Housing, Room 7248, U.S. Department of Housing and Urban Development, 451 Seventh Street, SW, Washington, D.C., 20410.

Definitions

Adjustment for Duplication: Enables the calculation of unduplicated output totals by accounting for the total number of households or units that received more than one type of HOPWA assistance in a given service category such as HOPWA Subsidy Assistance or Supportive Services. For example, if a client household received both TBRA and STRMU during the operating year, report that household in the category of HOPWA Housing Subsidy Assistance in Part 3C, Chart 1, Column [1] in the following manner:

Administrative Costs: Costs for general management, oversight, coordination, evaluation, and reporting. By statute, grantee administrative costs are limited to 3% of total grant award, to be expended over the life of the grant. Project sponsor administrative costs are limited to 7% of the portion of the grant amount they receive.

Beneficiary(ies): All members of a household who received HOPWA assistance during the operating year including the one individual who qualified the household for HOPWA assistance as well as any other members of the household (with or without HIV) who benefitted from the assistance.

Chronically Homeless Person: An individual or family who : (i) is homeless and lives or resides individual or family who: (i) Is homeless and lives or resides in a place not meant for human habitation, a safe haven, or in an emergency shelter; (ii) has been homeless and living or residing in a place not meant for human habitation, a safe haven, or in an emergency shelter continuously for at least 1 year or on at least 4 separate occasions in the last 3 years; and (iii) has an adult head of household (or a minor head of household if no adult is present in the household) with a diagnosable substance use disorder, serious mental illness, developmental disability (as defined in section 102 of the Developmental Disabilities Assistance and Bill of Rights Act of 2000 (42 U.S.C. 15002)), post-traumatic stress disorder, cognitive impairments resulting from a brain injury, or chronic physical illness or disability, including the co-occurrence of 2 or more of those conditions. Additionally, the statutory definition includes as chronically homeless a person who currently lives or resides in an institutional care facility, including a jail, substance abuse or mental health treatment facility, hospital or other similar facility, and has resided there for fewer than 90 days if such person met the other criteria for homeless prior to entering that facility. (See 42 U.S.C. 11360(2)) This does not include doubled-up or overcrowding situations to which the HOPWA project assisted beneficiaries to remain in stable housing during the operating year. See *Worksheet - Determining HOPWA Outcomes and Connections with HMIS* for definitions of stable and unstable housing situations.

In-kind Leveraged Resources: These are additional types of support provided to assist HOPWA beneficiaries such as volunteer services, materials, use of equipment and building space. The actual value of the support can be the contribution of professional services, based on customary rates for this specialized support, or actual costs contributed from other leveraged resources. In determining a rate for the contribution of volunteer time and services, use the criteria described in 2 CFR 200. The value of any donated material, equipment, building, or lease should be based on the fair market value at time of donation. Related documentation can be from recent bills of sales, advertised prices, appraisals, or other information for comparable property similarly situated.

Leveraged Funds: The amount of funds expended during the operating year from non-HOPWA federal, state, local, and private sources by grantees or sponsors in dedicating assistance to this client population. Leveraged funds or other assistance are used directly in or in support of HOPWA program delivery.

Live-In Aide: A person who resides with the HOPWA Eligible Individual and who meets the following criteria: (1) is essential to the care and well-being of the person; (2) is not obligated for the support of the person; and (3) would not be living in the unit except to provide the necessary supportive or services. See *Code of Federal Regulations Title 24 Part 5.403 and the HOPWA Grantee Oversight Resource Guide for additional reference.*

Master Leasing: Applies to a nonprofit or public agency that leases units of housing (scattered-sites or entire buildings) from a landlord, and subleases the units to homeless or low-income tenants. By assuming the tenancy burden, the agency facilitates housing of clients who may not be able to maintain a lease on their own due to poor credit, evictions, or lack

of sufficient income.

Operating Costs: Applies to facility-based housing only, for facilities that are currently open. Operating costs can include day-to-day housing function and operation costs like utilities, maintenance, equipment, insurance, security, furnishings, supplies and salary for staff costs directly related to the housing project but not staff costs for delivering services.

Outcome: The degree to which the HOPWA assisted household has been enabled to establish or better maintain a stable living environment in housing that is safe, decent, and sanitary, (per the regulations at 24 CFR 574.310(b)) and to reduce the risks of homelessness, and improve access to HIV treatment and other health care and support.

Output: The number of units of housing or households that receive HOPWA assistance during the operating year.

Permanent Housing Placement: A supportive housing service that helps establish the household in the housing unit, including but not limited to reasonable costs for security deposits not to exceed two months of rent costs.

Program Income: Gross income directly generated from the use of HOPWA funds, including repayments. See grant administration requirements on program income at 2 CFR 200.307.

Project-Based Rental Assistance (PBRA): A rental subsidy program that is tied to specific facilities or units owned or controlled by a project sponsor. Assistance is tied directly to the properties and is not portable or transferable.

Project Sponsor Organizations: Per HOPWA regulations at 24 CFR 574.3, any nonprofit organization or governmental housing agency that receives funds under a contract with the grantee to provide eligible housing and other support services or administrative services as defined in 24 CFR 574.300. Project Sponsor organizations are required to provide performance data on households served and funds expended.

SAM: All organizations applying for a Federal award must have a valid registration active at sam.gov. SAM (System for Award Management) registration includes maintaining current information and providing a valid DUNS number.

Short-Term Rent, Mortgage, and Utility (STRMU) Assistance: A time limited housing subsidy assistance designed to prevent homelessness and increase housing stability. Grantees may provide assistance for up to 21 weeks in any 52-week period. The amount of assistance varies per client depending on funds available, tenant need and program guidelines.

Stewardship Units: Units developed with HOPWA, where HOPWA funds were used for acquisition, new construction and rehabilitation that no longer receive operating subsidies from HOPWA. Report information is required for facilities that are subject to the minimum use requirements (three-year use agreement if rehabilitation is non-substantial and ten-year use agreement if rehabilitation is substantial).

Tenant-Based Rental Assistance (TBRA): TBRA is a rental subsidy program similar to the Housing Choice Voucher Program that grantees can provide to help low-income households access affordable housing. The TBRA voucher is not tied to a specific unit, so tenants may move to a different unit without losing their assistance, subject to individual program rules. The subsidy amount is determined in part based on household income and rental costs associated with the tenant's lease.

Transgender: Transgender is defined as a person who identifies with, or presents as, a gender that is different from his/her gender at birth.

Veteran: A veteran is someone who has served on active duty in the Armed Forces of the United States. This does not include inactive military reserves or the National Guard unless the person was called up to active duty.



Montana: Missoula, Open Aid Alliance

OAA served twenty-nine (29) households with TBRA assistance, surpassing their proposed goal of twenty-two (22) by seven (7). They served twenty-six (26) households with STRMU, surpassing their proposed goal of four (4) by twenty-two (22). Of the twenty-six (26) households that were served with STRMU, six (6) were later offered other HOPWA assistance, primarily TBRA. Sixteen (16) households received PHP assistance, surpassing their projected goal of eight (8) by eight (8). Fifty-nine (59) households received Supportive Services, surpassing their proposed goal of thirty-four (34). Every projected goal was exceeded. The strategy, based on a high demand for HOPWA, that has made this possible includes prioritizing all qualified individuals who have established forms of income. In this situation, HOPWA assistance can be leveraged to assist more individuals with a lower monthly financial commitment. In addition, OAA received additional funds from RiverStone to help additional families. OAA currently has a waiting list. They fill spots based on: need, financial means, length of time on waitlist, and likelihood of success in independent living. Referrals are received through the Ryan White program and the local Coordinated Entry initiative.

Montana: Billings, RiverStone Health

RiverStone Health served nineteen (19) households with TBRA assistance, coming short their proposed goal of twenty-three (23). They served four (4) households with STRMU, three (3) short of their proposed goal of seven (7). Those assisted presented a higher need and higher associated costs than anticipated. In addition, RiverStone inherited another agency's budget, transitioning as sponsor just before the operating year. The former sponsor had lower staff costs and RiverStone needed a higher ratio of staff costs. In addition, the agency did not have any presenting new households, so they gave a portion of their remaining budget to both OAA and ND. Two (2) households received PHP assistance, not meeting their goal of four (4). Twenty-five (25) households received Supportive Services, nine (9) short of their goal of thirty-four (34). Those receiving Supportive Services are clients that also received HOPWA housing services. Because RiverStone Health is the Ryan White provider for the area, they used leveraged Ryan White funds to assist other eligible clients with Supportive Services. Because of this, their total number of Supportive Service assisted clients is down for HOPWA and they did not spend a large amount of money in this category either. They do not currently have a waitlist.

South Dakota: Sioux Falls, SF Housing and Redevelopment Commission

SFHRC served thirty-three (33) households with TBRA, exceeding their proposed goal of fifteen (15). The variance resulted from several households exiting the program after no longer needing subsidized housing. This opened spots for new households to receive housing assistance. In addition, several households had increased income, resulting in a lower HOPWA subsidy, allowing SFHRC to distribute more funding to new households needing housing assistance. One (1) household received STRMU, meeting the proposed goal of one (1). SFHRC served seven (7) households with PHP, surpassing the the annual goal of three (3).

North Dakota: Bismarck, Community Action Program Region VII

CAP served ten (10) households with TBRA, surpassing their proposed goal of seven (7). They also served these same ten (10) households with Supportive Services. CAP received additional funds from RiverStone to help additional families. Community Action has case managers in 8 of the larger cities in ND which covers 7 regions. The housing coordinator oversees the HOPWA program across ND and the Case managers meet with the clients. At this time, they do not have a waitlist.

Montana: Missoula, Open Aid Alliance

Program accomplishments include stability among TBRA clients, although most will remain stable only with some form of HOPWA assistance. 100% of all recipients accessed Supportive Services in the form of Case Management and are following a housing plan.

Montana: Billings, Riverstone Health

With Riverstone Health taking over the HOPWA program as a sponsor agency in March of 2017, the program has increased and developed new relationships with private landlords, resulting in improved living situations.

South Dakota: Sioux Falls, SF Housing and Redevelopment Commission

87% of households receiving TBRA remained in stable/permanent housing.
 91% of households had contact with a case manager/benefits counselor and a primary health care provider.
 86% of households receiving case management were able to access/maintain a source of income.

North Dakota: Bismarck, Community Action Region VII

Households assisted were able to prevent homelessness and acquire stable and safe housing. Community Action agencies are able to provide other programs and services outside of HOPWA to assist clients to remain in their current housing, such as food, pantries, clothing, furniture, weatherization, and help with utilities using the energy share program. Referrals were made to medical service providers, mental health, RW, social service programs and ND job service. CAP has many types of rental assistance programs and therefore when a client comes into any of our offices we are able to provide services and also keep the client assured they are not identified as a HOPWA client or positive. Landlords as well, only know that the client is on a housing assistance program, not HOPWA. To address the challenges of affordable housing the housing coordinator regularly attends the statewide and regional housing coalition meetings.

Montana: Missoula, Open Aid Alliance

The limited SS budget limits the amount of time and energy that Case Managers can offer housing clients. Services are strictly limited to housing related assistance. OAA would like to offer more efficient wrap around services to clients in regard to employment and setting and meeting housing goals. At this time, housing stability is their primary focus and believe that with more SS funds, they would be able to increase housing and health outcomes.

Many of their clients are dealing with multiple diagnoses, making housing success and case management very challenging. Again, the SS budget is not sufficient to hire qualified mental health workers, yet many of the issues clients present with require such expertise. Credit history, rental history and criminal history present major barriers to clients and some end up living in subpar housing facilities because there are no other options given their multiple barriers.

Montana: Billings, Riverstone Health: See checked categories above

RiverStone Health took over as the HOPWA sponsor agency in March of 2017. The transition of services was not as streamlined as hoped and due to the clinic's high overhead cost, they must use leveraged funds to cover admin costs in order to stay below the 7% threshold.

South Dakota: Sioux Falls, SF Housing and Redevelopment Commission

Many households have poor credit or rental history which makes it challenging to find property owners who are willing to rent to them. There are also many immigrants with limited English language skills, especially in the Sioux Falls area, who have a difficult time locating housing due to language and cultural barriers. In some areas of the State (particularly Pierre and SF) households have trouble finding qualified housing within the FMR. Many cities/towns in SD have a shortage of affordable available housing due to low vacancy rates.

North Dakota: Bismarck, Community Action Region VII

Due to the population growth in ND, severe widespread floods and the oil boom in western and central ND, there is a housing shortage across the state. Most of the units are priced above FMR's. It is making it difficult for renters to find affordable and available housing across ND. ND is very rural which makes it difficult for clients to be close to services. Some renters currently in apartments are having rents increased which puts them above FMR's, so they have to move (housing shortage) or no longer qualify for the HOPWA program. Most landlords pull credit reports, criminal history and rental history which makes it difficult for tenants to find housing. Recommendations: Allow clients, if they can to pay the difference between the FMR and the rent amount s they will not lose their housing and become homeless. A budget would be worked on to determine if they could afford the apartment.

All of the Sponsor agencies including HOPWA grantee attended the HOPWA Institute Training in Tampa, FL in August 2017.

TA assistance through OneCPD has been exceptional and the service has been found helpful by our staff. Additionally, training based on the housing first model for staff to increase knowledge and ability to implement this model.

Montana: Billings, Riverstone Health: Riverstone has received TA from Cloudburst for APR reporting.

South Dakota: Sioux Falls, SF Housing and Redevelopment Commission: They did not list any TA

Stable Permanent Housing/Ongoing Participation

- 3 = Private Housing in the private rental or home ownership market (without known subsidy, including permanent placement with families or other self-sufficient arrangements) with reasonable expectation that additional support is not needed.
- 4 = Other HOPWA-funded housing assistance (not STRMU), e.g. TBRA or Facility-Based Assistance.
- 5 = Other subsidized house or apartment (non-HOPWA sources, e.g., Section 8, HOME, Public Housing).
- 6 = Institutional setting with greater support and continued residence expected (e.g., residential or long-term care facility).

Temporary Housing

2 = Temporary housing: moved in with family/friends or other short-term arrangement, such as Ryan White subsidy, transitional housing for homeless, or temporary placement in institution (e.g., hospital, psychiatric hospital or other psychiatric facility, substance abuse treatment facility or detox center).

Transitional/Short-Term Facility-Based Housing Assistance: Stable Housing is the sum of the number of households that (i) continue in the residences (ii) those that left the assistance as shown as items: 3, 4, 5, and 6. Other Temporary Housing is the number of households that accessed assistance, and left their current housing for a non-permanent housing arrangement, as reported under item 2. Unstable Situations is the sum of numbers reported under items: 1, 7, and 8.

Tenure Assessment. A baseline of households in transitional/short-term facilities for assessment purposes, indicate the number of households whose tenure exceeded 24 months.

STRMU Assistance: Stable Housing is the sum of the number of households that accessed assistance for some portion of the permitted 21-week period and there is reasonable expectation that additional support is not needed in order to maintain permanent housing living situation (as this is a time-limited form of housing support) as reported under housing status: Maintain Private Housing with subsidy; Other Private with Subsidy; Other HOPWA support; Other Housing Subsidy; and Institution. Temporarily Stable, with Reduced Risk of Homelessness is the sum of the number of households that accessed assistance for some portion of the permitted 21-week period or left their current housing arrangement for a transitional facility or other temporary/non-permanent housing arrangement and there is reasonable expectation additional support will be needed to maintain housing arrangements in the next year, as reported under housing status: Likely to maintain current housing arrangements, with additional STRMU assistance; Transitional Facilities/Short-term; and Temporary/Non-Permanent Housing arrangements.
